

# IKAA Gathering 2007 'Kidz Gathering' Daycare Liability Waiver

The International Korean Adoptee Associations Network, its member organizations, the individuals on the Board of Directors of any member organization, its officers, agents, assigns, KoRoot, volunteers in the Daycare Program, and any successors is collectively defined and will hereby be referred to as "IKAA".

I have asked IKAA to allow our child/ren to participate in the 'Kidz Gathering' Daycare Program arranged through KoRoot during the IKAA Gathering 2007, from July 31 – August 5, 2007. This program is for specified, scheduled day-time periods only, and does not cover childcare during evening hours. Outside the scheduled daycare hours, parents must resume care for their children.

I am aware that my child/ren, participating in the provided Daycare Program, will engage in various on-site activities outside of my presence and without my supervision. These activities may include cultural activities, arts and crafts and similar activities.

I have been given ample opportunity to obtain information and ask any and all questions about the Daycare Program, the supervisors and their background, skills and training, the activities in which they will be participating, or any other subject related to the Daycare Program. My family's participation in the Daycare Program is completely voluntary and based on an informed decision.

I acknowledge that for the benefit of contacting me (us) in the event that any questions or concerns arise with regards to my child/ren while participating in the Daycare Program, I have arranged for a local mobile phone and my contact number is \_\_\_\_\_. I also agree to pick up my child/ren at the specified pick-up time that will be posted daily at the Daycare site. I have seen the schedule and agree to pick up my child/ren on time or pay the fee of 10,000 KRW per child for every 10 minutes (or fraction thereof) past the pick up time. Violation of this policy will exclude me from further participation in the Daycare Program.

I/we understand that parents who take advantage of the offered Daycare Program are expected to sign up for chaperone duty at least once during the Gathering to help alleviate the difficulties the volunteers may encounter with regard to language and/or cultural differences and I agree to participate in this capacity.

In recognition of the possible risks which are inherent in the Daycare Program, and in consideration of IKAA and KoRoot's offering of the program, I do, for myself, my child/ren, and our heirs, executors, administrators, personal representatives, successors and assigns, knowingly, freely and voluntarily waive any right, claim, demand, action, cause of action, suit, controversy and liability of any kind or nature whatsoever against IKAA, as a result of, or arising out of, our participation in the Daycare Program.

IKAA does not own or operate any entity which provides, or is to provide, goods or services including, for example, facilities, food service providers, etc... As a result, IKAA is not liable for any negligent or willful act or failure to act of any such third person, or of any other third party.

Furthermore, I agree that I will never institute any suit or action at law or otherwise against IKAA, nor institute or prosecute or in any way aid in the institution or prosecution of any claim, demand, action or cause of action for damages, costs, loss of service, loss or injury whether to person or property, or both, whether developed or undeveloped, resulting or to result, known or unknown, which I or my child/ren ever had, now have or which I or my child/ren, our heirs, executors, administrators or personal representatives, hereafter can, shall or may have by reason of my/our involvement with IKAA and KoRoot or participation in the Daycare Program provided by IKAA through KoRoot for the duration of the IKAA Gathering 2007.

Should there be any dispute on or resulting from this agreement, an arbitration institution in a state to be agreed upon by both parties will be sought to adjudicate any such dispute.

I/we agree to maintain and use my/our individual or family health insurance in the event of any injury which my may be sustained as a result of my child/ren's participation in the 'Kidz Gathering' Daycare Program provided by IKAA through KoRoot and have attached a copy to be kept on file.
